CITATION-Any uniform mode of citation is accepted, footnotes should be used, and end notes are not allowed.

Papers will be peer reviewed by members of the committee, other independent reviewers. Once the paper is accepted, the authors should register within the prescribed date by paying the requisite fee.

Once the registration is done, the authors will be intimated to send a **power point presentation** of not less than 25 slides and not more than 30 slides, which will be uploaded in the website of the forum under virtual presentation section.

This virtual presentation section will enable all the participants to have access to all power point presentations.

Abstracts and papers will be published in online journal with ISSN as per the given schedule.
